Virginia529 is an Internal Revenue Code Section 529 qualified tuition program. A Section 529 college savings account is an individual savings account intended specifically for the payment of qualified higher education expenses for a designated beneficiary. Prize:

Seven (7) Virginia elementary schools will win one (1) set of financial literacy books for the school library (the Prize). The approximate retail value of each Prize is \$500.00.

By entering and participating in the Contest, each entrant fully and unconditionally agrees to and accepts the following Contest Terms & Conditions which are final and binding in all matters related to the Contest:

Eligibility:

1. Must be a U.S. citizen or legal U.S. resident and 18 years old or older at time of entry to enter.
2. Employees of Virginia529 and individuals engaged in the development, production or distribution of Contest materials, their advertising and promotion agencies and any and all other persons associated with the Contest and each of their immediate family members (spouse; parents, siblings, children, grandchildren and their spouses; and in-laws) and members of the same household (whether or not related) are not eligible to participate or win the Prize.
3. Must be a school librarian in a Virginia elementary school in a Virginia Association of School Librarians (VAASL) region.
4. Must read and discuss a book featured by the Reading Makes Cents program with students in at least one grade level.
5. Must provide the Reading Makes Cents Reading Challenge handout to all eligible students and promote the program within the school.
6. Must have at least 10% of the students in the elementary school participate in the Reading Makes Cents Reading Challenge. Participation rates will be determined by Virginia529, using results from the Reading Makes Cents Student Reading Challenge and Fall Membership data published by the Virginia Department of Education.
7. Must complete a post-program evaluation and submit the completed evaluation to Virginia529 by April 26, 2019.

Timing:

1. The Contest begins September 5, 2018 10:00AM ET and ends on April 12, 2019 5:00PM ET. Odds of winning depend on number of entries received in the Reading Makes Cents Student Reading Challenge.
2. One (1) Virginia elementary school per seven (7) VAASL regions with the highest Reading Makes Cents participation rate in each region will be declared the winner of the Prize. Participation rates will be determined by Virginia529, using results from the Reading Makes Cents Student Reading Challenge and Fall Membership data published by the Virginia Department of Education. Winners will be selected on or about May 10, 2019.

Virginia529 will use its best efforts to notify the winner by email on or about May 17, 2019. Submitted information becomes the property of Virginia529.
