

Reading Makes Cents Librarian Contest

Virginia College Savings PlanSM (Virginia529SM) an independent state agency of the Commonwealth of Virginia with its principal office located at 9001 Arboretum Parkway, North Chesterfield, VA 23236 is sponsoring a giveaway of seven (7) sets of financial literacy books valued at approximately \$500 to seven (7) Virginia elementary schools (the Contest). Virginia529 is an Internal Revenue Code Section 529 qualified tuition program. A Section 529 college savings account is an individual savings account intended specifically for the payment of qualified higher education expenses for a designated beneficiary. Customers are encouraged to obtain all enrollment materials, including the Program Descriptions, by calling 1-888-567-0540 or by downloading them from Virginia529.com and to read them carefully before investing. For residents of states other than Virginia: before investing, you should consider whether your or the beneficiary's home state offers any state tax or other state benefits such as financial aid, scholarship funds, and protections from creditors that are only available for investments in that state's qualified tuition program.

Prize:

Seven (7) Virginia elementary schools will win one (1) set of financial literacy books for the school library (the Prize). The approximate retail value of each Prize is \$500.00.

CONTEST TERMS & CONDITIONS

By entering and participating in the Contest, each entrant fully and unconditionally agrees to and accepts the following Contest Terms & Conditions which are final and binding in all matters related to the Contest:

Eligibility:

1. Must be a U.S. citizen or legal U.S. resident and 18 years old or older at time of entry to enter.
2. Employees of Virginia529 and individuals engaged in the development, production or distribution of Contest materials, their advertising and promotion agencies and any and all other persons associated with the Contest and each of their immediate family members (spouse; parents, siblings, children, grandchildren and their spouses; and in-laws) and members of the same household (whether or not related) are not eligible to participate or win the Prize.
3. Must be a school librarian in a Virginia elementary school in a Virginia Association of School Librarians (VAASL) region.
4. Must read and discuss a book featured by the Reading Makes Cents program with students in at least one grade level and/or share a link to a video recording of the selected book with students.
5. Must provide the Reading Makes Cents Reading Challenge handout or a link to the form to all eligible students and promote the program within the school.
6. Must have at least 10% of the students in the elementary school participate in the Reading Makes Cents Reading Challenge. Participation rates will be determined by Virginia529, using results from the Reading Makes Cents Student Reading Challenge and Fall Membership data published by the Virginia Department of Education.

Timing:

1. The Contest begins October 16, 2023 10:00 AM ET and ends on April 5, 2024 5:00 PM ET. Odds of winning depend on number of entries received in the Reading Makes Cents Reading Challenge. Virginia529's computer and staff are the official timekeeper for the Contest. **One entry per person regardless of method of entry.**
2. One (1) Virginia elementary school per seven (7) VAASL regions with the highest Reading Makes Cents Reading Challenge participation rate in each region will be declared the winner of the Prize. Participation rates will be determined by Virginia529, using results from the Reading Makes Cents Student Reading Challenge and Fall Membership data published by the Virginia Department of Education. Winners will be selected on or about May 31,

2024. Virginia529 will use its best efforts to notify the winners by email on or about June 7, 2024. Submitted information becomes the property of Virginia529.

Requirements of Winner:

1. Winners agree to comply with all participation requirements and to complete and execute all necessary documents including, but not limited to, waivers and releases. Prize winner has sixty (60) business days to reply or contact Virginia529 to claim the Prize or the Prize is forfeited.
